Council bans Stuart Robert over late payment for sports venue

the Gold Coast council after hiring the Runaway Bay Indoor Stadium to host three "Stuart Robert MP's Seniors Expos". Mr Robert, whose fundraising entity is understood to be the richest in the Liberal

National Party, was sent an "outstanding payments" letter by council chief executive Dale Dickson last Tuesday. Mr Dickson gave Mr Robert a discount of almost \$4000 on the amount owed, but

expressed disappointment the Gold Coast MP had failed to pay hire fees for expos between 2014 and this year. "It is quite clear that event hire and services have never been offered on a free-of-charge basis, as evidenced by the fact payment of \$1000 was made in 2013 and invoices were issued in 2014, 2015 and 2016," Mr Dickson said.

of Gold Coast venues can be accepted." Mr Robert confirmed last night that the bill had been outstanding until this week.

The 45-year-old MP said he hadn't paid the bill because council had not sent him invoices for the sports hall hires.

"They did not provide the invoice. I said to them: 'Where's the invoice?' That's the problem. They hadn't given me an invoice for three years," Mr Robert said. "They gave me the invoice and I paid it."

Asked about whether he was surprised the letter had been leaked, Mr Robert said: "There's a lot of love in the air at the moment."

The seniors' expo is attended annually by thousands of his constituents and has been held since at least 2010.

Mr Robert was dumped from the ministry last year over his associations with donors.

Queensland's anti-corruption watchdog launched an investigation this year after The

Australian revealed Mr Robert's fundraising arm had bankrolled the campaigns of staffers Kristyn Boulton and Felicity Stevenson, who ran as independents at this year's Gold Coast council election.

Mr Robert gave \$30,000 each to Ms Boulton, who was elected, and Ms Stevenson, who later returned to his office.

He provided a further \$10,000 to former Scenic Rim mayor John Brent.

All three ran at this year's council elections as "independent" candidates.

The donations came months after Mr Robert was dumped as a minister by Malcolm Turnbull, amid controversy over links to businessman and LNP donor Paul Marks.
